

LIMITED WARRANTY

A1 ARC PRIMA

A1 Americas Security Group LLC warrants that A1 Arc Prima Weldmesh System, Polyester coated, when properly installed, used, and maintained, will be free from defects in material and workmanship for up to 10 years from the date of delivery. Under this warranty, the polyester coated material is guaranteed not to fail under normal and proper usage. A1 Americas' obligation under this warranty shall be limited to replacing the Products which prove defective in material or workmanship, provided that the BUYER gives A1 Americas prompt notice (within two weeks after identifying) of any defect or failure and proof satisfactory to A1 Americas thereof. The customer shall pay for the removal of the old material or other elements and return to A1 Americas and pay for the replacement panel or element at the then current price, its delivery and its installation. A1 Americas will prorate the amount of damage as a percentage of the panel or element and the amount of time it was installed over the up to ten-year period, and credit the customer that amount toward the purchase of the new panel or element.

This limited warranty does not apply to damage to the Product caused by abrasive materials, corrosion of the Product due to aggressive fluids, lightning, icing up or other acts of God, excessive vibration, mechanical abuse, mishandling, misapplication, vandalism or improper installation.

This warranty is void if the Product is operated under unsafe and abnormal operating conditions.

In the event that the Product is altered or repaired by the BUYER without prior written approval by A1 Americas, all warranties are void. A new warranty period shall not be established for replaced Products. Replacements shall be covered by this warranty only for the remainder of the warranty period on the original products being replaced. No agent, employee, or representative of A1 Americas has any authority to bind A1 Americas to any representation, affirmation or warranty concerning the Product and any representation, affirmation, or warranty made by such person shall not be deemed to have become part of the basis of this sales contract and shall be unenforceable.
